## Major Research Interests

### 1. Precursors of the Chronic Diseases of Aging among Rural African Americans

Because many rural African American children, adolescents, and young adults live in low-SES circumstances, they are at elevated risk for health problems across their lifespans. Living in challenging rural Southern contexts can have deleterious effects on the functioning of biological stress regulatory systems and, ultimately, on health and psychological well-being. Prior to the SHAPE research program, little if any longitudinal, prospective research had been conducted on the contributions of contextual factors to the development of health vulnerabilities among African American youth. Health-relevant biomarkers were added to SHAPE to allow assessment of the hypothesis that contextual risks would presage the development of health disparities among rural African American youth and young adults. Because not all SHAPE participants go on to develop poor health, protective processes were also identified that might alter the normative risk curve. This research showed that SES- and race-related stressors in rural Southern contexts, as well as exposure to the economic downturn of 2007, were manifested at (a) the systemic level, with pro-inflammatory cytokines and protein markers of inflammation; (b) the genomic level, with markers of epigenetic aging; and (c) the stress regulatory system, with markers of cortisol, catecholamines, and blood pressure. Statistical models suggested buffering scenarios wherein youth who received supportive parenting and developed positive racial identities did not experience the biological consequences of exposure to SES- and race-related stressors.

### 2. Skin-Deep Resilience: Self-Control Forecasts Better Psychosocial Outcomes but Higher Health Risks

Socioeconomic disparities persist in many aspects of American child development. Relative to their affluent peers, low-SES children complete fewer years of education, and have more health problems. On the basis of research indicating that low self-control underlies some of these disparities, policymakers have begun incorporating character-skills training into school curricula and social services. Emerging data from our research group suggest that, for low-SES youth, self-control may act as a double-edged sword, facilitating academic success and psychosocial adjustment while undermining physical health. Adolescents from low-SES backgrounds with better self-control displayed resilience as young adults. They displayed fewer depressive symptoms, and less substance use, rule breaking, and aggressive behavior, as young adults. To the extent they had better self-control, however, low-SES children showed greater cardiometabolic risk as young adults, as reflected on a composite of obesity; blood pressure; the stress hormones cortisol, epinephrine, and norepinephrine; and accelerated epigenetic aging. Similar conclusions emerged in subsequent analyses of the same cohort, which mapped the trajectories of a subgroup who would normatively be viewed as resilient. These individuals had graduated from high school and were attending college despite living in challenging neighborhoods with concentrated poverty. Compared with other participants, they smoked and used other drugs less at age 20, but this resilience was only "skin deep." Despite academic success, these youth showed relatively poor cardiometabolic health at age 20.

### 3. Health Benefits of Participation in Family-Centered Prevention Programs

Because of the dearth of prevention programs and services for African American children, adolescents, and young adults in the rural South, three developmentally appropriate, family-centered programs designed to prevent drug use and HIV-related risk behavior were developed by Dr. Brody, and their efficacy was demonstrated. The Strong African American Families (SAAF) program was developed for preadolescent youth, the Strong African American Families–Teen (SAAF–T) program was developed for adolescents, and the Adults in the Making (AIM) program was developed for young adults. These programs are being used in communities throughout the nation. They are not only efficacious in deterring drug use and risk behavior, but also have health benefits as demonstrated by ameliorating genetic risks; reducing catecholamine levels and inflammation; and contributing to longer telomere lengths and lower epigenetic aging in immune cells.
